2012 Democratic Precinct Caucus Declaration of Candidacy to Run as a Delegate for the Legislative District Caucus and County Convention

Rule 16 of the **2012 Precinct Caucus Rules** states the following:

"A person not present at the caucus may be elected a delegate or alternate if s/he states in writing that s/he is a Democrat and is willing to be known as such, is supporting a named candidate or "uncommitted," and will serve if elected. Such a **Declaration of Candidacy** letter does not constitute a vote and is not counted in the allocation of delegates and attendees. A person submitting such a declaration may serve only if elected by others in attendance at the appropriate preferential caucus."

Submitting a copy of this exact **Declaration of Candidacy** is not required. This document however, does serve as a useful template.
