Political Facts of Note

Millennials, the generation born between 1981 and 1996, have typically been quite detached from politics when compared to other generations. For example in 2014 46% of millennials were looking forward to the midterm as compared to 60% for baby boomers. This is unfortunate since, according to years of polling, they are also the most liberal generation in American history and are the single largest group of voting age adults.

However, as with many things, Trump seems to be changing this. In a poll conducted last month 60% of millennials were excited for the midterm, only slightly lower than the 62% of baby boomers. It's hard to read that as anything other than Trump waking up millions of voters to the necessity of political participation.

What has Dan Newhouse (R-WA4) done for Us lately? By Richard Badalamente

This is a recurring column in the newsletter. In it we'll introduce examples of legislation sponsored/co-sponsored, or otherwise supported by Mr. Newhouse that might make one question just who our representative thinks he's representing.

In January 2017, Rep Dan Newhouse co-sponsored H.R. 38, a bill to allow concealed carry reciprocity. This bill amends the federal criminal code to allow a "qualified individual" to carry a concealed handgun into or possess a concealed handgun in another state that allows individuals to carry concealed firearms. Additionally, the bill specifies that a qualified individual who lawfully carries or possesses a concealed handgun in another state: (1) is not subject to the federal prohibition on possessing a firearm in a school zone, and (2) may carry or possess the concealed handgun in federally owned lands that are open to the public. Given that Nicolas Cruz, who shot to death 17 students and wounded 15 others last Valentine's Day, passed a background check, would he be ex post facto considered "qualified?"

March for Our Lives

A March for Our Lives event was held at 3pm at Howard Amon Park in Richland on March 24. Approximately 2000 people were in attendance, including a few counter-protesters. The event was supported by Love Army Tri-Cities, Benton County Democrats (See the press release at http://www.bencodems.org/docs/PressRelease03212018.pdf), Tri-City Democrats and Benton County Republicans (see their press release at: www.bentoncountygop.com/).



A series of compelling presentations were made by the students and others. Some of the participants engaged the counter protesters in conversation, which the counter protesters appreciated. We should all be very proud of the positive interactions that were had.

The Epidemic of Gun Violence in America By Richard Badalamente

More people in the United States are killed, or kill themselves by firearms than in any other advanced country in the world. There were 61,527 incidences of gun violence in America in 2017 (not including suicides), accounting for 15,593 deaths, an average of 1300 per month. There were 346 mass shootings in 2017. As of this writing, there were already 34 mass shootings in 2018. There are more mass shootings in America than in any other country in the world.

NRA lobbyists and members of Congress should watch on closed circuit TV as ER doctors frantically sort through the bloody goo of shredded tissue, shattered bone, and macerated organs trying frantically save a life. Would they then have the audacity to repeat their hackneyed refrain, "Guns don't kill people, people kill people?"

People with guns kill people and today's modern firearms kill more people, faster. Apologists for the AR-15 argue that it is "only semi-automatic," i.e., firing the rifle requires a trigger pull for each shot. That's true, but they automatically reload between shots and a shooter can empty a 30-round magazine in 15 to 30 seconds, depending on who's bragging.

Going back to when I retired from the U.S. military at the end of 1981, more semi-automatic handguns had been used in mass shootings than semi-automatic rifles, like the AR-15. However, the AR-15 has become de rigueur for those seeking maximum carnage. AR-15s have been used in five of the six deadliest mass shootings in the last six years in the U.S.

The 1994 Federal Assault Weapons Ban, signed by then President Clinton, outlawed 19 types of military-style assault weapons. A clause directed that the ban expire in 10 years unless Congress specifically reauthorized it, which, of course, it did not.

Under federal law, one must be 21 to buy a handgun from a firearms dealer. Eighteen year-olds can buy an AR-15. Younger buyers can purchase any gun (including an AR-15) from unlicensed gun dealers. To fix this loophole, Washington waives sales tax on transactions with unlicensed sellers when a background check is performed.

Gun laws and their effective enforcement vary from state to state. There is a 3-day waiting period in Florida to purchase a handgun, but no waiting period to purchase an AR-15, the weapon used in the MSD High School mass shooting last Valentine's Day.

Washington gun laws require a 5-day waiting period before purchasing handguns. No such waiting period is required for semi-automatic rifles, such as the AR-15, although a bill before the Senate would change this.

In 2016, Washington voters approved Initiative-1491, Extreme Risk Protection Orders. It is now 7.94 RCW. It temporarily prevents individuals who are at high risk of harming themselves or

others from accessing firearms by allowing family, household members, and police to obtain a court order when there is demonstrated evidence that the person poses a significant danger, including danger as a result of a dangerous mental health crisis or violent behavior. Florida doesn't have such a law. Perhaps if it did, an unimaginable tragedy might have been averted.

We can't know with certainty how many lives might be saved if Congress took seriously their responsibility to serve the people by enacting sensible measures to combat gun violence. What we can know for sure, is that enough members of Congress take NRA money so seriously that the chances of passing meaningful legislation is slim to none. Only by replacing these politicians with those who have a moral compass will we finally see our nation on a path to curing its epidemic of gun violence.

PCO Committee Activities

Precinct activities are happening! The State Party's Canvass Host program is up and running, along with the Rise & Organize training program which is setting records in attendance and volunteer recruitment! 
Benton County Convention and Legislative District 8 Caucus

On March 24 a combined Benton County Democratic Central Committee Convention and Legislative District 8 (LD8) Caucus was held as Desert Hills Middle School. Delegates for the State Convention were nominated and elected during the LD8 Caucus. The County Platform was approved during the County Convention portion of the meeting. The platform committee developed a values and principles based platform that was four pages in length (as compared with the previous platforms 32 pages). There was discussion about points related to energy policy, capitalism, corporate personhood, the universality of valuing freedom, democracy, human rights and equitable prosperity, and the strength of our military.
